

# License agreement

Stuffed Guys, Inc  
End User License Agreement

## THE SOFTWARE

Stuffed Guys, Inc (SG) has created a server-based, proprietary, project management software called "Factory Nova" ("the Software").

## LICENSE GRANT

SG grants to you, on these terms and conditions, the non-exclusive right and license to use the Software on one installation to be accessible by one URL (web address).

## TERMS

The Software is offered under a "major version" license. The license terms feature technical support and service plus access to minor upgrades to the Software. A new major version of the Software will require you to purchase a new license in order to use it. "Major version" is determined by a new first digit in the Software's version number.

## SCOPE OF GRANT

You may:

- Customize the Software's design and operation to suit the internal needs of your business except to the extent not permitted in this Agreement.
- Create applications which interface with the operation of the Software provided said application is an original work.

You may not:

- Reverse engineer, disassemble, or create derivative works based on the Software for distribution.
- Modify the source code in the part that concerns the licensing mechanism of the Software (change the number of allowed active users or projects, the type of the installed license, etc).
- Modify and/or remove any copyright notices on Software's pages (unless an additional "Copyright removal" license is purchased) and in the header of any source files.
- Distribute the Software.
- Distribute individual copies of files, libraries, or other programming material in the Software package.
- Distribute or modify proprietary graphics, HTML, or CSS packaged with the Software for use in Software applications other than Factory Nova without written permission from SG.
- Remove or modify file "pub.license.php" located inside directory "actions" in the Software package.
- Block or restrict public web access to "index.php?sc=pub&action=license" URL inside the Software's installation directory.

## **COPYRIGHTS**

You acknowledge that the Software and its documentation are protected by copyright and other laws and that SG is the sole owner of all rights in and to the Software and its documentation. You have no rights in the Software or its documentation except as set forth in these terms and conditions and in any other written agreement you may have with SG.

## **PROPRIETARY LABELS**

Authorization to remove or modify copyright notices is only given with a "Copyright removal" license purchased separately from SG. This license authorizes you to remove SG copyright notice in the output that the Software produces (such as html pages). "Copyright removal" license does not give you authorization to remove any copyright notices in the program source files or any other rights.

## **TRANSFER OF LICENSE**

You are not allowed to transfer this license to any other party without expressed written consent of SG.

## **TERMINATION**

This Agreement will terminate automatically upon failure to comply with the limitations described herein or on written notice from an authorized representative of SG. On termination, you must destroy all copies of the Software within 48 hours. Termination of the license due to noncompliance will not result in any refunds of license fees.
